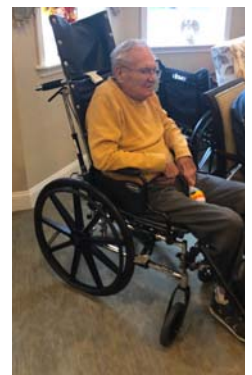

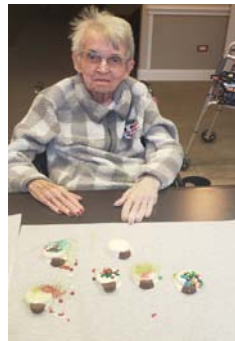
Music Therapy

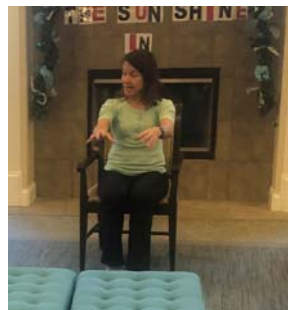
